New measures to save mothers are announced by the British Minister of Health (Sir Kingsley Wood) in a report on maternity mortality in England, published last night.

Coalfield Stand-Still on May Day. Miners in all pits in the South Wales coalfield on Mouday cease work for their May Day demonstrations. Meetings will be addressed by miners' M.P.s, and a composite resolution will be submitted. This welcomes the recently improved wage agreement, but expresses the miners' actermination to persist in the campaign for still higher wages.

Plague of Foxes in France. A plague of foxes has attacked the Charente region in France, especially round the famous brandy district of Cognac.

English Cigarettes in Coffin. A daring attempt to smuggle an immense quantity of English cigarettes in a coffin into France has been foiled by the customs officials at Marseilles. On the arrival of the mail boat from Corsica, a coffin laden with flowers was lowered reverently over the side of the ship and placed on a hearse. Roosevelt Signs Naval Bill. President Roosevelt left early yesterday for a ten day tarpon fishing trip in the warm waters of the Gulf of Mexico. Airwoman Held Up by Weather. Mrs. Bonney, the Australian airwoman, who is flying in stages from Australia to South Africa, has been held up at Bangkok by bad weather.

South African Corruption Trial Sequel. A Bloemfontein telegram says the appeal of Colonel Cilliers, Chief of the South African Railway Police, against a sentence of five years hard labour on a charge of defeating the ends of justice, was upheld by the Appellate Court yesterday. Chinese Hawkers Expelled.

Alleged mass expulsion by the German police of Chinese hawkers, who tour the country selling pottery to housewives, led to a delegation of ten of the hawkers being received by the Chinese Ambassador, Dr. Cheng, at the Embassy in Berlin yesterday. While they waited for their interview with the Ambassador the delegation appeared very excited, and cried "China should not tolorate this."

International Sugar Agreement. The International Sugar Conference last night announced that the agreement to be embodied in a convention aims at maintaining the free market and extending it by promoting increased consumption; it establishes a system of export quotas. It is proposed that the agreement should be for five years.

Defence of the Franc. M. Vincent Auriol, the French Finance Minister told the Finance Commission of the Chamber that the franc would not be allowed to go below the limit set by the Monetary Law, that is about 112 francs to the pound. Strong reserves existed to defend the franc, he declared.

Woulfe Of Abbeyfeale.

SYMPATHY. The death of Mr. Richard B. Woulfe, M.P.S.I., of New Street, Abbeyfeale, aithough not unexpected, from his prolonged illness, is widely regretted throughout Limerick and Kerry. Dick Woulfe, as he was popularly known, may be said to have sacrificed his life to the national cause, for there is little doubt the hardships to which he was exposed during the Black and Tan war undermined a sturdy constitution, while acting as M.O. of the Brigade and A.S. Unit of the Old I.R.A. in West Limerick. He was associated with many hazardons operations against the British forces, and never shirked the more dangerous risks connected with them. He was to a great extent responsible for the comfortable treatment of General Lucas in the West Limorick area after he had been kidnapped near Mallow, and he saw to it that the General was accorded all the aircuities to which a commander of his rank while prisoner of mar was entitled to.
